Over the past year, the IP sector has witnessed a hotspot, with growing emphasis on IP innovation driving related trends in the legal services market. On the policy front, China issued the 2024 Action Plan for Advancing Intellectual Property Development. This plan highlights improving IP systems, strengthening IP protection, enhancing market mechanisms, and raising the quality of public IP services. It also outlines measures for fostering a supportive social and cultural environment for IP, deepening engagement in global IP governance, and strengthening organizational support.

Recently, the World Intellectual Property Organization (WIPO) released the 2024 Global Innovation Index and IP Metrics. In the report, China was ranked the economy with the most service and technology innovation clusters in the second consecutive year. Shenzhen being Rong-Guanghui, Beijing, and Shanghai-Sunrise were all ranked among the most significant innovation hubs of 2024.

With the continuous rise in IP applications, the quality and innovation of IP subjects have significantly improved. Meanwhile, the growing value and complexity of IP litigation cases have intensified competition in the legal services market, where demand is steadily increasing. This dynamic environment places higher burden, and more innovative demands on IP lawyers.

The year's list of 15 leading IP lawyers showcases professionals known for solving complex legal disputes, their strategic insight, sharp business acumen, and commitment to emerging trends.

Some of the recognized leaders share with ALB their key achievements, professional experience, and strategic strengths in navigating China's IP landscape over the past year.
